We received your request for an exempt distribution license and a sealed source device registration along with check number 1037 in the amount of \$500.00. However, the application fees (10 CFR Part 170.21) for the exempt distribution license (fee category 3H) that you requested is \$4,300 and for the sealed source device registration (fee category 9A) is \$7,700. Therefore, fees in the amount of \$11,500 (less the \$500 received) must be submitted before the approval process for this license and registration can begin.
