APPENDIX D OF 10 CFR PART 52

1. In a letter dated September 21, 2012, and as supplemented by letters dated October 29, 2012 and January 25, 2013, Southern Nuclear Operating Company (licensee) requested from the Nuclear Regulatory Commission (Commission) an exemption from the provisions of Title 10 of the *Code of Federal Regulation* (10 CFR) Part 52, Appendix D, Section III.B, "Design Certification Rule for the AP1000 Design, Scope, and Contents," as part of license amendment request 12-008, "Definition of Wall Thicknesses for Nuclear Island Buildings, Turbine Buildings, and Annex Building" (LAR 12-008).

For the reasons set forth in section 3.1 of the NRC staff Safety Evaluation, which can be found at Agencywide Document Access and Management System Accession Number ML13074A178, the Commission finds that:

- A. the exemption is authorized by law;
- B. the exemption presents no undue risk to public health and safety;
- C. the exemption is consistent with the common defense and security;
- D. special circumstances are present in that the application of the rule in this circumstance is not necessary to serve the underlying purpose of the rule;
- E. the special circumstances outweigh any decrease in safety that may result from the reduction in standardization caused by the exemption; and
- F. the exemption will not result in a significant decrease in the level of safety otherwise provided by the design.

2. Accordingly, the licensee is granted an exemption to the provisions of 10 CFR Part 52, Appendix D, Section III.B, to allow deviations from the certified Design Control Document (DCD) Tier 1 Table 3.3-1, as described in the licensee's request dated September 21, 2012 and as supplemented on October 29, 2012 and January 25, 2013. This exemption is related to, and necessary for the granting of License Amendment No. 6, which is being issued concurrently with this exemption.
3. As explained in section 5.0 of the NRC staff Safety Evaluation (ADAMS No. ML13074A178), this exemption meets the eligibility criteria for categorical exclusion set forth in 10 CFR 51.22(c)(9). Therefore, pursuant to 10 CFR 51.22(b), no environmental impact statement or environmental assessment needs to be prepared in connection with the issuance of the exemption.
4. This exemption is effective as of the date of its issuance.
