Enclosed with this letter is the Croft response to the RAI posed by the NRC on March 22<sup>nd</sup>, 2013, with regards to the Croft package 3977A. This includes a matrix detailing our response (CTR 2013/04), an updated SAR (CTR 2008/11, Revision 2) and several supporting documents as listed below. These documents include Croft proprietary information that we request is withheld from public disclosure. As required by 10 CFR 2.390 we hereby submit an affidavit regarding this proprietary information.

Regarding the questions raised in RAI 5.1 we have concluded that the shielding evaluation carried out for the steel insert is not sufficient. In order to allow the package approval to continue at this time, we request that the package is reviewed only for the tungsten inserts and their contents. The steel insert information has been left in the SAR so that at a future date, we may add the steel inserts and the contents as approved contents.
