Thank you for forwarding the 3/29/13 letter. The snail mail copy of that letter addressed to our Tribal Chair has not yet surfaced!

I understand there will be no ground disturbance involved in this undertaking, but I do wish to review a map showing the Area of Potential Effects. The area is considered sensitive for Wiyot villages as mapped by Loud (1918), however, it is useful to learn that no artifacts or sites were identified when PG&E constructed the Humboldt Bay ISFSI - can you provide me with a copy of that reference?

Once I have heard back from you about my requests, I will confer with the THPOs at Bear River Band and Wiyot Tribe and follow up with comments as appropriate. Please inform me of the deadline for comments, and include this letter in the official record.
