Dear Mr. Bush:

I am writing to provide U.S. Nuclear Regulatory Commission (NRC) staff comments on a U.S. Department of Energy report entitled "August 2012 Groundwater and Surface Water Sampling at the Tuba City, Arizona, Disposal Site" dated November 2012. Note that the NRC did not receive this report until April 2013. NRC staff has reviewed the subject report and have the following comment:

It appears that 13 of the approximately 35 extraction wells were not sampled because the pumps at these wells were not functioning. It is not clear from the report if the pumps have been repaired or replaced because the reports states that no corrective action was taken.
