Gentlemen,

VY has provided the final counts for GE reports and INRs regarding the steam dryer inspections.

There are 3 RFO24 evaluations, 1 RFO25 evaluation, 2 RFO26 evaluations, 1 RFO27 evaluation and 1 RFO28 evaluation to make 8 in all.

There are 4 INR's from GE for RFO24, 7 INF's from AREVA for RFO25, 17 INR's from GE for RFO26, 24 INR's from AREVA for RFO27, 23 INR's from AREVA for RFO28 and 1 INR from GE for RFO29. These INR's and INF's from GE and AREVA are just for the steam dryer and note that there are sometimes more than one indication per INR or INF.
