NRC Generic Letter 83-10a requested that licensees provide justification for the treatment of Reactor Coolant Pumps (RCP's) during transients and accidents either on an individual utility basis or by reference to a generic Owners Group submittal. By letter dated May 31, 1983, SCE indicated that San Onofre Units 2 and 3 would operate RCP's consistent with the CEOG "trip two, leave two" strategy.

NRC Generic Letter 86-06 requested information regarding the implementation of TMI Action II.K.3.5 "Automatic Trip of Reactor Coolant Pumps" and the schedule for providing this information to the NRC. The purpose of this letter is to provide the NRC with SCE's schedule of October 31, 1986 for submittal of the Automatic RCP trip information as requested by NRC Generic Letter 86-06.
