This letter provides Southern California Edison's (SCE) schedule for submitting follow-up information and analysis regarding the San Onofre Nuclear Generating Station (SONGS), Units 2 and 3, Main Steam Safety Valves (MSSV). This information was discussed in a meeting in Rockville, Maryland on May 23, 1989. The meeting was held to discuss the SONGS MSSVs with the NRC. Since then, SCE has provided the NRC with an informational Licensee Event Report, LER No. 2-89-010 dated June 30, 1989. In addition, the MSSV ring settings for SONGS Unit 2 have been reset to generic values to achieve the stamped capacity lift. As discussed with the NRC Project Manager, the blowdown and overpressure analytical work for both SONGS Units 2 and 3 is continuing. Under the present schedule, SCE's report regarding the SONGS MSSVs will be completed and forwarded to NRC by December 15, 1989.
