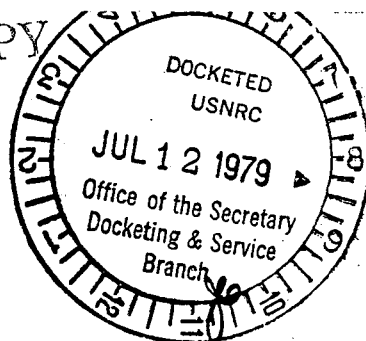

RE: Licensing of San Onofre Nuclear Generation Stations 2 and 3

We, the undersigned, petition the Commissioners to the Nuclear Regulatory Commission (NRC) to deny operating licenses for San Onofre Nuclear Generating Stations 2 and 3.

These plants were originally licensed for construction by the NRC with supporting data from the 1973 Rasmussen Report (WASH 1400). Recent rejection of this report by the NRC places the safety of the reactors and associated equipment in further doubt.

The location of the plants in close proximity to an active earthquake fault magnifies the danger to nearby large population centers. The evacuation plans for these areas are unworkable and unrealistic.

These safety considerations and the unresolved problem of permanent and terminal disposition of high-level radioactive waste argue for a denial of an operating license to these plants.
