Reference is made to your letter dated October 2, 1978 to Southern California Edison and San Diego Gas and Electric Companies (Applicants) in which you requested that the Applicants conduct a program to further identify and assess archaeological, historical and cultural resources which may be affected by San Onofre Nuclear Generating Station, Units 2 and 3. The Applicants have evaluated the request and agree to conduct the program as requested.

The program to be conducted by Applicants is outlined as follows:

1. Archaeological/Historical Survey:

Archaeological/historical reconnaissance level or full surveys will be conducted on transmission lines in order to identify archaeological/historical interest sites and assess their eligibility for the National Register. All new transmission lines being constructed for San Onofre Units 2 & 3 which have not been previously surveyed and assessed will be fully surveyed as part of this program. For the existing lines and substations identified below, reconnaissance level surveys will be conducted where no effects of construction and maintenance are expected. Full surveys will be conducted where there will be direct impact by construction and/or maintenance of the transmission lines.
