The Applicants met in the NRC offices in Bethesda, Maryland, on January 9, 1979, with members of the NRC staff and personnel from Oak Ridge National Laboratory. The meeting was requested by the Applicants to present comments and information pertaining to the NRC's analysis of the thermal plume for the subject project.

In the process of the Applicants' presentation, data from ongoing environmental monitoring programs was presented. This data further substantiates previous data which indicates that certain conditions and assumptions used in the NRC's analysis of thermal plume dispersion are unrealistic. Enclosed with this letter are six (6) copies of this supplemental data from the ongoing environmental monitoring programs for the review and information of the NRC staff.
