hereby submit Amendment Application No. 18.

This amendment application consists of the following proposed
changes to Facility Operating License NPF-10, Technical Specifications
incorporated as Appendix A:

Proposed Change NPF-10-62 is a request to revise Technical
Specification Sections 3/4.3.2 (Table 3.3-5) ENGINEERED SAFETY FEATURES
ACTUATION SYSTEM INSTRUMENTATION and 3/4.5.2 ECCS SUBSYSTEMS - Tavg GREATER
THAN OR EQUAL TO 350°F. The proposed change allows plant modifications to
mitigate the consequences of simultaneous occurrence of a Safety Injection
Actuation Signal and a Recirculation Actuation Signal.

Proposed Change NPF-10-64 is a request to revise Technical
Specification 4.5.2.f EMERGENCY CORE COOLING to reduce High Pressure Safety
Injection Pump performance requirements for power levels less than 83%.

Pursuant to 10 CFR 170.22, each of Proposed Changes NPF-10-62 and NPF-10-64 is considered to constitute a Class III amendment. The basis of this determination is that these changes involve safety issues.

Accordingly, the fee of \$8,000.00 corresponding to this determination is remitted herewith as required by 10 CFR 170.22.

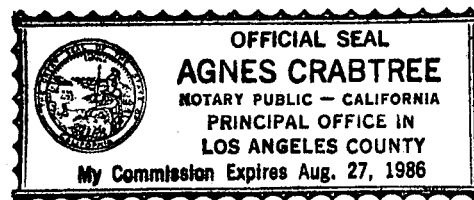

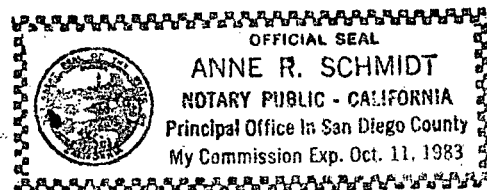

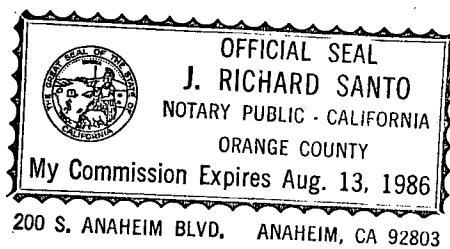
