Monthly Operating Reports for February 1990
San Onofre Nuclear Generating Station, Units 2 and 3

The purpose of this letter is to provide the Monthly Operating Reports required by Section 6.9.1.10 of Appendix A, Technical Specifications (TS) to Facility Operating Licenses NPF-10 and NPF-15 for San Onofre Nuclear Generating Station, Units 2 and 3, respectively. The reports cover routine operating statistics and shutdown experience during the reporting period.

TS Section 6.9.1.10 also requires reporting challenges to the safety valves, any changes to the Offsite Dose Calculation Manual (ODCM), or any major changes to the radioactive waste treatment systems. During this reporting period, the main steam safety valves and one of the two pressurizer safety valves for Unit 3 were challenged following a reactor trip on February 23, 1990. Also during this period, changes to the Units 2 and 3 ODCM were made and became effective on February 10, 1990.

A brief summary of a challenge to the Unit 3 safety valves is included in this month's reports. The affected pages associated with Revision 20A of the Units 2 and 3 ODCM will be submitted within 90 days from the time the change was made effective. There were no major changes to the Units 2 and 3 radioactive waste treatment systems during the reporting period.
