SCE's letter of March 22, 1982 submitted Amendment Application No. NPF-10-1 in Docket 50-361 for the San Onofre Nuclear Generating Station, Unit 2. No. NPF-10-1

This amendment consists of Proposed Change No. 1 to
the Technical Specifications incorporated in Facility Operating
License No. NPF-10 as Appendix A. Proposed Change No. 1 is a
request to revise Appendix A Technical Specification
3.4.8.3.1.a to clarify the Code requirements for the Shutdown
Cooling System (SDCS) Relief Valve consistent with existing
clarification for the Pressurizer Safety Valves. No physical
changes are required to the plant.

The amendment clarifies existing ASME Code requirements for this Code-compliant valve. Accordingly, it is concluded that (1) the proposed change does not involve an unreviewed safety question as defined in 10 CFR 50.59, nor does it present significant hazard considerations not described or implicit in the Final Safety Analysis, and (2) there is a reasonable assurance that the health and safety of the public will not be endangered by the proposed change.

Pursuant to 10 CFR 170.22, Proposed Change No. 1, submitted as Amendment Application No. NPF-10-1, is determined to be a Class II change. The basis for this determination is that the change has no safety or environmental significance.

Accordingly, the fee of \$ 1,200.00 corresponding to this determination is remitted herewith as required by 10 CFR 170.22.
