Enclosed for your review and approval is a copy of a proposed change to Technical Specification 4.8.4.1.a.2 for San Onofre Nuclear Generating Station, Unit 2 (Operating License NPF-10). The proposed change is a request to eliminate the Trip Setpoint and Response Time data from Table 3.8-1, Containment Penetration Conductor Overcurrent Protective Devices.

NRC approval of the proposed change is requested to facilitate the entry of Unit 2 into Operational Mode 4 which may occur as early as Friday, April 9, 1982. A formal request for an amendment to Operating License No. NPF-10 detailing this proposed change will be transmitted to the NRC during the week of April 12, 1982. The formal request will include a check in the amount of \$1,200.00 for this change which has been determined to be a Class II change in accordance with 10CFR170.22.
