By letter dated September 30, 1982, SCE requested early approval of Proposed Change NPF-10-46 to allow entry into Modes 3 and 2 while the turbine control valves were undergoing repairs. Early NRC approval of Proposed Change NPF-10-46 was given on October 7, 1982. In accordance with SCE's September 30, 1982 letter, Proposed Change NPF-10-46 is hereby formally submitted.

It is respectfully requested that Amendment Application No. 13 be reviewed promptly and appropriate action taken. Direct distribution of Amendment Application No. 13 to Facility Operating License No. NPF-10 will be made in accordance with the service list provided by SCE's letter of August 2, 1982 to the Commission. An affidavit attesting to the fact that distribution has been completed will be submitted within ten days of amendment docketing.

The proposed changes contained in Amendment Application No. 13 are considered to constitute a Class II amendment based on the determination that these changes have no safety or environmental significance. Accordingly, enclosed is Southern California Edison Company's check in the amount of \$1,200.00 as required by 10 CFR 170.22.
