Pat and Stacy,

This is a brief update on the industry efforts related to Doel 3.

- As you probably know, we have established a date for a public meeting: January 8.
- We have not been very successful with Electrabel in getting them to grant us access to their analyses. Our latest update is that the deterministic analysis is thus far favorable.
- Because of the lack of success with Electrabel, we intend to perform our own probabilistic analysis using the FAVOR code. It looks like this will complete by the end of March and we will discuss our progress on the analysis during the public meeting.
- The industry survey results are due back in early December. I will let you know when we get the results assembled.
