San Onofre Unit Generating Station
Units 2&3

The purpose of this letter is to provide estimates of the dates by which San Onofre Nuclear Generating Station Unit 2 can support fuel load based on (1) construction completion and (2) availability of licensed operators. This information is provided to support preparation of the NRC monthly report to Congress.

Consistent with industry practice the project construction schedule has been adjusted to be consistent with the projected license date. Thus the current SCE projection for construction completion is December 1, 1981. This date is derived from the Atomic Safety and Licensing Board estimate of Thanksgiving for issuance of an initial decision concerning the low power license contentions.

SCE cannot precisely define a date for completion of operator licensing at this time. However, it is reasonable to state that licensed operators will be available by about January, 1982.
