This letter is to affirm the implementation of maintenance program procedures as required by license condition 2.C(5)c. The San Onofre Unit 2 component maintenance program has been implemented. The program meets the following requirements:

1. Maintenance procedures have been developed based on manufacturers recommended maintenance practices.
2. Station and Project procedures or directives require that environmentally qualified components are maintained in their as tested configuration with the exception of the auxiliary feedwater pump motors. This exception is allowed under license condition 2.C(25).
3. Equipment that has been environmentally qualified is identified in SCE's Revision 2 to the "Environmental Qualification Report per requirements of NUREG-0588" submitted to the NRC on November 6, 1981. Each piece of equipment requiring environmental qualification has been reviewed for potential age related degradation as described in the report. The result of this review is that no additional maintenance activities beyond manufacturers recommendations other

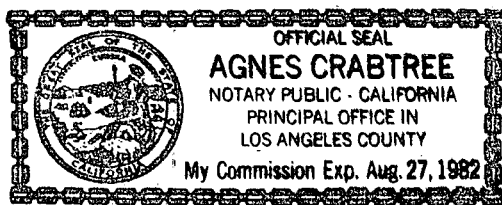
than replacement of certain subcomponents, are required at this time with respect to aging. The review has determined that all environmentally qualified components have at least a 2 year qualified life after initial criticality (The qualified life is, of course, a function of operating history and may prove to be longer than two calendar years). Replacement schedules for parts subject to age related degradation will be incorporated into the maintenance program prior to the time components exceed their qualified life.
