SUBJECT: SUMMARY OF PUBLIC MEETING TO DISCUSS PRELIMINARY
DRAFT CHANGES TO NUREG-0654 / FEMA-REP-1

On October 29, 30, and 31, 2013, a Category 3 public meeting was held by the U.S. Nuclear Regulatory Commission (NRC), in conjunction with the Federal Emergency Management Agency (FEMA), to engage stakeholders and the public regarding preliminary draft changes to NUREG-0654 / FEMA-REP-1, "Criteria for Preparation and Evaluation of Radiological Emergency Response Plans and Preparedness in Support of Nuclear Power Plants." The meeting was held with organizational stakeholders and members of the public attending at NRC offices, 11545 Rockville Pike, Rockville, MD 20852, or remotely participating via webinar and teleconference. A listing of meeting attendees is contained in the attached enclosure.

The purpose of the meeting was to provide stakeholders and the public an opportunity to discuss with NRC and FEMA staff preliminary draft changes to evaluation criteria associated with each emergency preparedness (EP) planning standard prior to issuing draft Revision 2 of NUREG-0654/FEMA-REP-1 for formal public comment, which is currently scheduled for October 2014. The preliminary draft evaluation criteria for discussion at the meeting were made publicly available on September 19, 2013 located in the NRC Agencywide Documents Access and Management System (ADAMS) under Accession No. ML13260A283.
