Dear Mr. Snee:

We have reviewed the final revisions to the Ohio regulations in the Ohio Administrative Code Chapters 3701:1-38-14, 3701:1-38-22, 3701:1-40-16, 3701:1-40-17, 3701:1-44-14, 3701:1-44-25, 3701:1-56-05, 3701:1-56-18, and 3701:1-56-19 received by our office on November 25, 2013. These regulations were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) rules in 10 CFR Parts 20, 30, 40, and 70 and the requirements of the amendment identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with Mark Light on December 20, 2013.

As a result of our review, we have no comments. Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that the regulations, as adopted, meet the compatibility and health and safety categories established in the Office of Federal and State Materials and Environmental Management Programs (FSME) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."

The SRS Data Sheet summarizes our knowledge of the status of other Ohio regulations and legally binding requirements, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet.
