## General Comment

The Draft Generic Environmental Impact Statement (DGEIS) is inadequate. In particular, storing nuclear waste next to rivers such as the Altamaha and the Savannah Rivers in Georgia is a very bad idea, and shuffling radioactive waste around to "interim" storage facilities is even worse. NRC should stop issuing reactor licenses until a real repository is determined. That would be a repository situated on bedrock that would be stable for thousands of years.
