SUBJECT: REQUEST FOR CONSENT TO DIRECT LICENSE TRANSFER AND
AMENDMENT

Dear Mr. Pitt:

By the letter dated November 27, 2013, Dearborn Cardiology Associates submitted to the U. S. Nuclear Regulatory Commission (NRC) a Request for Consent to Direct License Transfer of NRC Materials License 21-32196-01. Based on the information provided, we understand that all of Dearborn Cardiology Associates' stock has been purchased by Oakwood Health Care System. This transaction resulted in control of Dearborn Cardiology Associates being directly transferred to Oakwood Health Care System. We further understand that this transfer will not result in any change to the licensed materials, persons using the license material, location of use of licensed material, or persons responsible for the licensee's radiation safety program. However, the name will be changed to Oakwood Cardiovascular Associates.

Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of the request, the NRC consents to the direct transfer of control. Enclosed is Amendment No. 8 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

The transferee Oakwood Health Care System should note their new responsibility and liability as an NRC licensee. Specifically, responsibility is emphasized with regard to any ongoing NRC inspection and enforcement issues, investigations, facility decontamination and decommissioning funding resources. Please be advised, change of ownership/control cannot be transferred without **prior** written consent from the NRC (10 CFR 30.34 (b)). 
Also, please note we have removed the license condition regarding decommissioning financial assurance because this condition no longer applies to your licensed activities.

The NRC published in the *Federal Register* (76 FR 34773; June 14, 2011), its policy statement on safety culture. This policy statement sets forth agency expectations that individuals and organizations involved in NRC-regulated activities establish and maintain a positive safety culture proportionate to the safety and security significance of their activities and the nature and complexity of their organizations. Additionally, the NRC has developed a brochure (NUREG/BR-0500, "Safety Culture Policy Statement," issued June 2011) and a Regulatory Issue Summary 2012-01 dated January 17, 2012 (ML112940226) that are intended to aid stakeholders in understanding the safety culture traits.
