**Sybase Software Annual License Renewals**

On December 24, 2013, as a result of a sole source solicitation, a firm-fixed price purchase order (GS35F5212H/NRC-HQ-10-14-T-0001) was awarded to SAP National Security Services, Inc., of Newtown Square, PA for the renewal of the annual software maintenance support for Sybase Relational Database Management System (RDBMS) which is required to comply with the Business Application Support System's. The support provides day-to-day operation to BASS in order for several applications of the Sybase RDBMS to function properly. This is a 1-year contract and the period of performance is from January 1, 2014 to December 31, 2014. The total value of the value of the award is \$255,019.80.

**List of Approved Spent Fuel Storage Casks: Transnuclear, Inc. Standardized NUHOMS® Cask System: Direct Final Rule; Confirmation of Effective Date; 10 CFR Part 72 (RIN 3150-AJ10; NRC-2012-0020)**

On December 27, 2013, the NRC confirmed in the *Federal Register* ([78 FR 78693](#)) the effective date of January 7, 2014, for the direct final rule that was published in the *Federal Register* on October 24, 2013 ([78 FR 63375](#)). This direct final rule amended the NRC's spent fuel storage regulations by revising the Transnuclear, Inc. Standardized NUHOMS® Cask System listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 11 to Certificate of Compliance No. 1004.

**Amendments to Material Control and Accounting Regulations and Proposed Guidance for Fuel Cycle Facility Material Control and Accounting Plans and Completing the U.S. Nuclear Regulatory Commission Form 327: Notice of Rescheduled Public Meeting and Extension of Comment Period; 10 CFR Parts 40, 70, 72, 74, and 150 (RIN 3150-AI61; NRC-2009-0096 and NRC-2013-0195)**

On December 30, 2013, the NRC published a document in the *Federal Register* ([78 FR 79328](#)) rescheduling a public meeting that was cancelled due to inclement weather and extending the public comment period for a proposed rule and draft guidance on material control and accounting of special nuclear material. The public meeting has been rescheduled for January 9, 2014. The public comment period has been extended to March 10, 2014, in response to a request by stakeholders.
