Dear Mr. Stuckmeyer

We are requesting that the U.S. NRC review whether a change of control is applicable (NUREG-1556, Vol. 8, Appendix F). If it is determined that a change of control is applicable, then we are requesting that our present license be transferred to FLIR Detection, Inc. a wholly-owned subsidiary of FLIR Systems, Inc.

1. FLIR Radiation, Inc. has officially changed its name to FLIR Detection, Inc. Attached is a copy of the new Charter from the State of Tennessee.
2. FLIR Detection, Inc. remains a wholly-owned subsidiary of FLIR Systems, Inc ("FLIR"), an Oregon Corporation. FLIR is headquartered at 27700 SW Parkway Avenue, Wilsonville, Oregon, 97070. 3. We confirm that no changes to personnel or duties that relate to the licensed program have changed. Jeff Preston will remain the RSO. James Burdick is the general manager of FLIR Detection, Inc. All personnel handling the exempt quantity radionuclide kits have undergone in-house training and undergo regular training on at least an annual basis.
4. There was only a name change. No transfer of stocks, mergers, etc. took place.
5. We confirm that no changes in the location, facilities, equipment or procedures related to the existing program have occurred.
6. We confirm that there are no changes in the use, possession, location, or storage of the licensed materials.
7. We confirm that all surveys and reports are current. This includes instrument calibrations, records and reports of all transfers, internal surveys, training and inventories.
8. FLIR Systems, Inc. and FLIR Detection, Inc confirms that it will abide by all constraints, conditions, requirements and commitments as specified in the existing licensed program from FLIR Radiation, Inc.
