Your letter of November 21, 1974 advised us that your intent in requesting that we perform periodic checks of the material in the San Onofre Local Public Document Room was that we take appropriate steps to see that amendments to the safety analysis report are filed or incorporated if this has not been done by the librarian. As indicated in our letter of May 19, 1972, wherein we agreed to periodically check the Public Document Room for the availability of certain documents pertaining to San Onofre Units 2 and 3, compliance with your request requires a page-by-page examination of several thousands of pages of material to make the determination you suggest with reasonable assurance. Moreover, the value of such determinations is somewhat questionable because documents could be misplaced almost immediately after a check was completed since we have no control of the material. Therefore, the check would only verify the material was complete at the time of the check.


Nevertheless, in addition to continuing the periodic checks described in our letter dated May 19, 1972, in the

future, we will replace missing volumes of the safety analysis report, environmental report and all amendments to the docket which are determined to be missing by our periodic checks.
