

San Onofre Nuclear Generating Station
Units 2 and 3

Our letters to Mr. B. J. Youngblood of July 29, 1975 and to Mr. O. D. Parr of March 25, 1976 stated that information concerning plans for compliance with 10 CFR 50 Appendix I for the subject plant would be provided in the operating license application. Appendix I indicates that this information should be provided by June 4, 1976 for plants which filed a construction permit application prior to January 2, 1971.

As you know, an application for a construction permit for San Onofre Units 2 and 3 was filed in June, 1970; however due to licensing delays associated with issuance of the construction permits (October, 1973), our application for an operating license is now scheduled for November of 1976. Based on our long standing plans of incorporating information concerning compliance with Appendix I in our operating license application and delays in receipt of NRC guidance with regard to implementation of Appendix I, it is requested that the NRC approve pursuant to 10 CFR §50.12 our proceeding in the manner described in our letters of July 29, 1975 and March 25, 1976.
