

Shaw AREVA MOX Services, LLC ("MOX Services") makes the following corrections to its filing with the Atomic Safety and Licensing Board ("Board") on June 14, 2013, in the above captioned matter. MOX Services makes these changes to conform its filing with the current and applicable procedural rules at 10 C.F.R. Part 2, adopted August 3, 2012:

1. At page 142, paragraph 6.3, change "fifteen (15) days after service of this Partial Initial Decision" to "twenty-five (25) days after service of this Initial Decision";
2. At page 142, paragraph 6.3, change "Within ten (10) days after service" to "Within twenty-five (25) days after service"; and
3. At page 142, paragraph 6.3, before the final sentence add, "The petitioning party may file a reply brief within ten (10) days of service of any answer."
