The following information is being supplied as directed by Appendix G of NUREG – 1556, Vol. 9, Rev. 2 in support of a request for a transfer of control regarding the above mentioned facility:

1. The license for Henlopen Cardiology, P.A./Habib Bolourchi, M.D will be terminated and all of the activities currently performed under it will be performed under Molecular Imaging Services, Inc. (License #: 07-30790-01, Docket #: 030-36176) as an additional location of use effective as of March 1, 2014. Frank DiGregorio (302-750-3668) will continue to serve as Radiation Safety Officer for Molecular Imaging Services, Inc., and should be contacted if more information is needed.
2. There will not be any changes in personnel due to the transfer of control.
3. The current surveillance program (surveys, wipe tests, QC) is ongoing and will not be interrupted by the transfer of control.
4. There are no plans for a formal decommissioning of the facility as the same equipment currently onsite, and personnel, will continue to be used in the same location by the transferee as was used by the transferor.
5. The transferee will abide by all constraints, conditions, requirements, and commitments of the transferor.
6. Habib Bolourchi, M.D. will become an Authorized User on License No. 07-30790-01 for 35.100 and 35.200 uses.

Molecular Imaging Services, Inc. will be adding a new location. The address is 2700 Silverside Road, Suite 3A, Wilmington, DE 19810. A scaled floor plan is attached for your review. All relevant information related to the areas of use and storage of Radioactive Materials is noted on the floor plans.
