The purpose of this letter is to request authorization to initiate feed inlet and commence operation of Assay 4 Cascade 9. Louisiana Energy Services, LLC (dba URENCO USA [UUSA]) has successfully performed procedure OP-3-0450-03, IROFSC23 Surveillance Procedure, Revision 9 and has demonstrated that Cascade 4.9 meets the requirements of IROFSC23.






### Affidavit
