This is in follow-up to your January 15 and 16, 2014, telephone conversations between you and Mr. Dennis O'Dowd of my staff regarding the Department of Interior's (DOI) financial assurance for decommissioning. During these conversations, Mr. O'Dowd indicated that DOI is required to provide a revised Statement of Intent (SOI) to reflect the radionuclides currently authorized on your NRC License Number 24-12728-01.

Based on information you provided during the conversations, it is our understanding that you are currently in the process of coordinating the disposal of lead-210, cadmium-109, cesium-134, and nickel-63, and that the disposal will occur during the week of January 20, 2014. It is also our understanding that after the material is properly disposed, you will submit an amendment request to reduce the possession limits on your license, and include a revised SOI that accurately reflects the radionuclides and possession limits described in your license.

It is our understanding that you will submit the amendment request to reduce licensed possession limits, along with a revised SOI, no later than January 31, 2014. If your understanding differs from the above, please contact me immediately at (630) 829-9868 to provide clarification.
