Discussion: Mr. Reichard confirmed that Mr. Franco's best contact information is 787-590-6001 and rfranco@isser.com. Mr. Franco said that they currently possess one radiography source, but that it should be disposed of on January 14 or 15, 2014. Mr. Franco said that the storage location and mailing address (a P.O. Box) remain unchanged, though their offices have moved. Mr. Reichard asked if ITER intended to perform radiographic operations in the future. Mr. Franco said that they want to resume radiographic operations in the middle of 2014. Mr. Reichard verified that Mr. Franco knew that he was going to need to hire or train a new RSO, apply to reactivate the license, and comply with 10 CFR Part 37 after March 19, 2014. Mr. Franco said that he was aware of 10 CFR Part 37, but admitted that he's going to have to spend time learning how to comply before they return to operation.
