Dear Mr. Diaz,

This is in reference to your letter dated November 12, 2013, requesting for amendment to Nuclear Regulatory Commission License No. 19-31389-01. In order to continue our review, we need the following additional information:

1. In your letter you stated that T.L.B. Associates has been sold to Soil and Land Use Technology, Inc. by a comprehensive stock purchase. NUREG-1556, Volume 15, "Consolidated Guidance About Materials Licenses Program-Specific Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source., or Special Nuclear Material Licenses" requires a complete description of the transaction. Some information about the transaction is needed.
  - a. What was the date of the transaction.
  - b. Provide evidence of the transaction.
  - c. Who previously owned the stock.
2. On the second item of your letter, you told us that the Radiation Safety Officer would be Mr. Clive Diaz. You did not state if there were any other changes in personnel. In the telephone conversation on December 16, 2013, you stated that Mr. William Wainger, CEO, will be the management contact. NUREG-1556, Volume 15, "Consolidated Guidance About Materials Licenses Program-Specific Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source., or Special Nuclear Material Licenses" states, "Changes in personnel that need to be documented include individuals having control over licensed activities. This may include, in some cases, officers of a corporation or other management individuals who are listed on the license or referred to in the supporting documentation." Please describe all changes of personnel that include individuals having control over licensed activities or state that there are no other changes in personnel.
3. The letter was signed by the proposed Radiation Safety Officer. The letter needs to be signed by T.L.B. Associates, Inc. management contact and a management representative of Soil and Land Use Technology, Inc.

We will continue our review upon receipt of this information. Please reply to my attention at the Region 1 Office (Address below) and refer to Mail Control No. 582568. If you have technical questions regarding this letter, please call me at (610) 337-5366. Please only submit information that is not proprietary and can be made publically available.
