Cabrera Services, Inc. (Cabrera) has provided radiological and chemical characterization and survey data as part of a CERCLA (Comprehensive Environmental Response, Compensation, and Liability Act) action at Great Kills Park, Staten Island, NY. Cabrera provided characterization and survey data to help determine the nature and extent of radioactive contamination at the site under a contract to the U.S. Army Corps of Engineers (USACE). The USACE is providing engineering and management services to the National Park Service (NPS) in support of this CERCLA action. Radium source identification and removal are part of a Time Critical Removal Action (TCRA) associated with the CERCLA action.

This amendment revises the completion date from December 31, 2013 to July 31, 2014 to permit the removal of certain radioactive materials accumulated during the TCRA. This includes removal and disposal of 52 uCi of radium currently staged at the site in a locked container.

Small, localized, unexcavated hotspots, and general areas of elevated radioactivity remain onsite. Characterized ground areas exceeding 2.0 mR/hr on contact were reasonably protected from casual contact through use of chain link boundary fencing or heavy steel plates to cover hotspots. After adding these ALARA measures, contact dose rates were determined to be less than 2.0 mR/hr on contact with the steel plates or at the fence boundary of each area. Ongoing surveillance & maintenance of fenced/protected areas will be the responsibility of fencing and steel plate ALARA measures to be performed by others.

No other radiological controls, additional radiation worker training, personnel dosimetry, or removal of sources/artifacts is contemplated by Cabrera at this time. Other unaffiliated radiological contractors are continuing the TCRA and providing radiological controls including release of equipment and materials from the site.

This information is being transmitted to you as required by condition 18A of the Cabrera Materials License.
