SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
FOR HOPE CREEK GENERATING STATION (TAC NO. MF1896)

Dear Mr. Joyce:

By PSEG Nuclear LLC (PSEG) letter LR-N13-0197, Enclosure 4, dated August 27, 2013, and GE-Hitachi Nuclear Energy Americas LLC (GEH) affidavit dated August 22, 2013, executed by Ms. Linda C. Dolan, PSEG requested that the information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.390:

Hope Creek Generating Station PRNM [power range neutron monitor] Phase 0
Meeting Slides

A non-proprietary copy of the document has been placed in the Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (4)a. Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by GEH's competitors without license from GEH constitutes a competitive economic advantage over other companies; and
- (4)b. Information that, if used by a competitor, would reduce their expenditure of resources or improve their competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and



Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the document.
