OPPORTUNITY TO PARTICIPATE IN UPCOMING URANIUM RECOVERY WORKSHOPS (FSME-14-033)

Purpose: To inform the Agreement States of the upcoming Uranium Recovery (UR) workshops and to solicit interested participants.

Background: To provide the Agreement States with the opportunity to participate in a workshop on the revised draft Interim Staff Guidance (ISG) FSME-ISG-01, "Evaluations of Uranium Recovery Facility Surveys of Radon and Radon Progeny in Air and Demonstrations of Compliance with 10 CFR 20.1301" and a workshop on Uranium Recovery Lessons Learned with a focus on the Section 106 tribal consultation process and efficiencies for conducting reviews.

Discussion: On April 2, 2014, in Rockville, Maryland, we are holding a workshop on the revised draft Interim Staff Guidance (ISG) FSME-ISG-01, "Evaluations of Uranium Recovery Facility Surveys of Radon and Radon Progeny in Air and Demonstrations of Compliance with 10 CFR 20.1301." The draft ISG has been published and is available to the public in the Agencywide Documents Access and Management System (ADAMS) under Accession No. ML13310A198. This ISG provides guidance to the U.S. Nuclear Regulatory Commission's staff for evaluating uranium recovery (UR) licensee demonstrations of compliance with the public dose limits.

The *Federal Register* notice should be published in a few days. The notice will specify the public comment period.*

The radon workshop is a category 3 public meeting - meaning public participation is actively sought.
