The purpose of this modification is to provide \$604,000 of incremental funding, thereby increasing the total obligation amount from \$294,000 to \$898,000; of which \$53,880 represents fixed-fee and \$844,120 represents cost.

As a result, section A.1 CONSIDERATION AND OBLIGATION--TASK ORDERS (AUG 2011), subsection (c) is revised as follows:
