By the Reference 1 letter, Union Electric Company (Ameren Missouri) submitted a license renewal application (LRA) for Callaway Plant Unit 1. In Reference 2 dated February 12, 2014 the NRC transmitted the thirtieth (30th) Request for Additional Information (RAI) related to the application.

Ameren Missouri provided a partial response to the February 12, 2014 RAI regarding the Callaway reactor vessel internals clevis insert bolt design and 2013 inspection results in Reference 3. This letter transmits additional supporting information related to materials and heat treatment methods at these locations. Enclosure 1 of this letter supplements the original RAI response and refers to information provided by Westinghouse Electric Company LLC (Westinghouse).
