Purpose: This is to inform you that the U.S. Nuclear Regulatory Commission (NRC) has published a proposed rule for comment to modify 10 CFR Parts 170 and 171 regarding the licensing, inspection and annual fees to recover approximately 90 percent of its fiscal year (FY) 2014 budget authority.

Background: These amendments are reviewed annually to support budget needs to implement the Omnibus Budget Reconciliation Act of 1990 (OBRA-90), as amended, which mandates that NRC recover through fees approximately 90 percent of its FY 2014 budget authority less the amount appropriated from the Waste Incidental to Reprocessing (WIR) and generic homeland security activities. The proposed rule would modify the fees assessed to those Agreement State licensees who perform work in Non-Agreement States under the reciprocity provisions of 10 CFR 150.20.
