Dear Mr. Caines:

This is a follow-up to the letter which Ms. Margie A Kotzalas, U.S. Nuclear Regulatory Commission (NRC), sent to you. This letter, dated August 20, 2013, informed you that the NRC would be issuing new Sealed Source and Device (SS&D) registration certificates to replace the ones which had been issued previously by the Georgia Environmental Protection Division (GAEPD) because the authority to issue Sealed Source and Device registrations has been transferred from the GAEPD to the NRC.

Please note that we have issued a new registration certificate NR-0571-D-105-B to replace GA-0571-D-105-B, dated August 15, 2013. A copy of the new registration is enclosed. Furthermore, please note that we are also working on issuing new registration certificates to replace your other GAEPD certificates, and we will transmit these new certificates accordingly once they are complete.

Please be advised that you must manufacture and distribute any registered product in accordance with the statements and representations contained in your application, with enclosures thereto, and the information set out in your registration certificate. As a general rule, you must request and obtain an amendment to the certificate before you make changes or modifications to the information submitted to obtain the certificate.

Please read over the enclosed registration certificate in its entirety and notify us immediately of any errors or omissions.

You are obligated to notify us promptly in writing should you decide to no longer manufacture, distribute, or offer service support for the product.
