

1. The purposes of this modification are:
 - a. Reduce the fixed hourly labor rates in this BPA so that they are the same as those in GSA Federal Supply Schedule (FSS) Contract No. GS35F0617Y under which this BPA was awarded; and
 - b. To exercise Option Year 1 in this BPA, thereby extending the period of performance through February 28, 2015.
2. As a result of this modification, the following modifications are made to the text in the BPA:
 - a. Item No. 5 of the first page of the BPA is modified to read as follows: "This BPA expires on February 28, 2015 or at the end of the contract period, whichever is earlier."
 - b. Section B.12 of the BPA is modified to read as follows:

"This BPA expires on February 28, 2015 or such later ending date as determined by the exercise of any option."
 - c. The price schedule for Option Years 1, 2 and 3 contained in section B.4 of the BPA is modified to read as follows:
