


**14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)**

The purpose of this modification is to (1) extend the period of performance of the Task Order at no additional cost to the Government from March 17, 2014 to April 18, 2014 and (2) provide incremental funding in the amount of \$11,000.00, thereby increasing the obligated amount from \$178,700.00 to \$189,700.00. Accordingly, Section 1 CONSIDERATION AND OBLIGATION-COST-PLUS FIXED FEE (JUN 1998) ALTERNATE I (JUN 1991) paragraph (c) of this task order is revised as follows: The amount currently obligated by the Government with respect to this contract is \$189,700.00, of which the sum of \$175,746.00 represents the estimated reimbursable costs, and of which \$13,954.00 represents the fixed fee. Section 2, TASK/DELIVERY ORDER PERIOD OF PERFORMANCE is revised as follows: The period of performance of this order shall be 9/17/2012 through 4/18/2014.
