Dear Mr. Siegrist:

By letter dated February 10, 2014, you provided notification to the U. S. Nuclear Regulatory Commission (NRC) of a change in scope and extension of the work activity period for work activities at a temporary jobsite in Staten Island, New York. This letter was a follow-up to your letter dated October 22, 2013 (Agencywide Documents Access and Management System (ADAMS) Accession Number ML13305A093) providing notification to the NRC in accordance with Condition 18.A of your NRC license.

In our letter dated March 24, 2014, (ADAMS Accession Number ML14083A593) responding to your October 22, 2013 letter, the NRC communicated our determination that the Great Kills Park site was not an area of exclusive Federal jurisdiction and thus your planned work activities at this location did not require an NRC license. Therefore, because the location of your planned work activities has not changed, the change in scope of the planned activities does not require an NRC license. In our March 24, 2014 letter, we further indicated that Cabrera Services, Inc. should seek guidance from the State of New York's Agreement State Program to determine the appropriate regulatory requirements and authorizations needed for the work activities planned at Great Kills Park.
