SUMMARY

Discussed the following items relative to the licensee's request stated above:

1. The faxed copy of the Certificate issued by the American Board of Radiology (ABR) for Michael E. Farber, M.D. is not legible. Only the title, "American Board of Radiology" and Dr. Farber's name are visible. The licensee was requested to submit a new copy that is legible. **Dr. Slack stated that he would photograph the certificate and resubmit a legible copy.**
2. A NRC Form 313A(AUD) was submitted for Dr. Farber; however, the pages containing Part II "Preceptor Attestation" of the form are missing and were not submitted. A proper preceptor attestation will need to be submitted prior to any action to authorize Dr. Farber for 35.100 and 35.200 materials and uses. **Dr. Slack stated that he would review his information and obtain the missing pages.**
3. The NRC Form 313A(AUT) that was submitted in support of 35.300 authorization for Dr. Farber indicates that his training and experience, specifically, supervised clinical casework, was limited to oral administration of sodium iodide-131 in quantities less than or equal to 33 millicuries (mCi), although the precepting AU, Dr. Jerry Froelich, attested that Dr. Farber had met the requirements of 35.390. **Dr. Slack understood that Dr. Farber could not be authorized for all 35.300 materials and uses based on the information provided, but would seek this further authorization sometime at a later date.**

Dr. Slack stated that he would respond with the additional information and clarifications next week.

NOTE: The reviewer called Dr. Slack on 02/07/14 to inform him that Item 2 above was no longer needed, as the missing pages were in the request packet, just not in the proper order and therefore, these pages were initially overlooked. DOD
