SUMMARY

Dr. Browne provided that:

- 1) The Sr-90 ophthalmic source was properly disposed of and the licensee has no longer possessed Sr-90 ophthalmic source. The licensee would like to remove it from the license.
- 2) The licensee has possessed only one HDR unit (Nucletron Model No. 105.002). The other HDR was properly transferred to other authorized license.
- 3) The licensee will continue keep the depleted uranium and Am-241 sealed source (Amersham Model AMC-24) in storage and plan to transfer them to other authorized license in this year.

Please provide a confirmation for items 1, and provide a copy of the transferring record for the HDR that was transferred and a statement that there was no leaking sources associated with that HDR while it was under your license.
