SUBJECT: POWERTRONIC SYSTEMS, INC. REQUEST FOR ADDITIONAL
INFORMATION CONCERNING TERMINATION OF THE LICENSE

Dear Mr. Stafford:

This letter refers to the license termination request dated March 31, 2014. In order to continue our review, we need the following additional information.

Title 10, *Code of Federal Regulations*, Chapter 32 (10 CFR 32), section 32.29 requires each person licensed under § 32.26 to maintain records of transfer of byproduct material and file a report with the Director of the Office of Federal and State Materials and Environmental Management Programs by an appropriate method listed in § 30.6(a), including in the address: ATTN: Document Control Desk/Exempt Distribution.

Section 32.29 requires licensees who permanently discontinue activities authorized by the license issued under § 32.26 to file a report for the current calendar year within 30 days after ceasing distribution. Section 32.29© states that If no transfers of byproduct material have been made under § 32.26 during the reporting period, the report must so indicate.

Please provide the report required by 10 CFR 32.29. To facilitate the processing of your amendment request, please send a copy of your report directly to me at the following address:

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue termination of your license.
