2. The current ceiling of the contract is hereby increased by \$56,262.56, from \$3,454,965.56 to \$3,511,228.12.
3. Incremental funding in the amount of \$65,000.00 is hereby obligated. Funds are increased by \$65,000.00, from \$2,774,660.80 to \$2,839,660.80.
4. Section B.2 – Consideration and Obligation – Labor Hours is hereby revised as follows:
 - (a) The total estimated amount of this contract (ceiling) for the product/services ordered, delivered, and accepted under this contract is \$3,511,228.12 for the base period through option year three. The total estimated value of the contract ceiling, for the entire contract, is \$3,511,228.12.
 - (b) The amount presently obligated with respect to this contract is \$2,839,660.80.

All other terms and conditions remain unchanged.
