ORDER

(Public Release of Partial Initial Decision)

On April 10, 2014, the Board advised that it had issued a Third Partial Initial Decision (LBP-14-03) ruling in favor of Nuclear Innovation North America, LLC on Contention FC-1.¹

During the course of the hearing on this matter, the Board received testimony and exhibits that contain confidential business information. To ensure that such information is not inadvertently disclosed, the Board directed the parties to propose redactions to this Partial Initial Decision.²

On April 17, 2014, the parties filed a joint response proposing redactions, in which they stated that the "reason for each redaction is to prevent the release of confidential business information that should not be disclosed to the public."³ Accordingly, submitted concurrently with this Order is a redacted copy of LBP-14-03 that varies from the original version only in that (1) the header and footer designating the decision as non-public have been removed; and (2) four redactions have been made. The Office of the Secretary is authorized to place a copy of
