- Minimal impact on end users



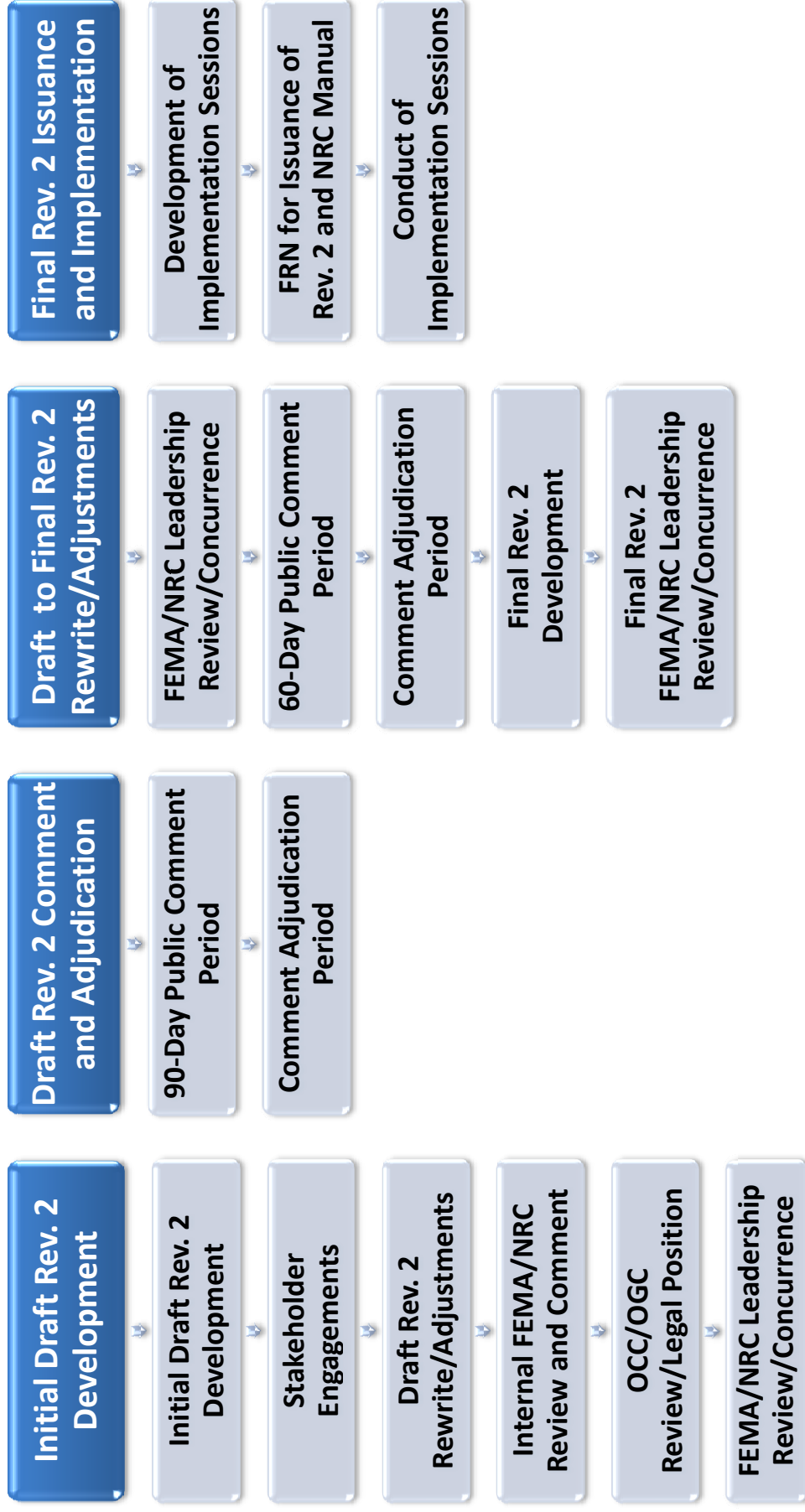

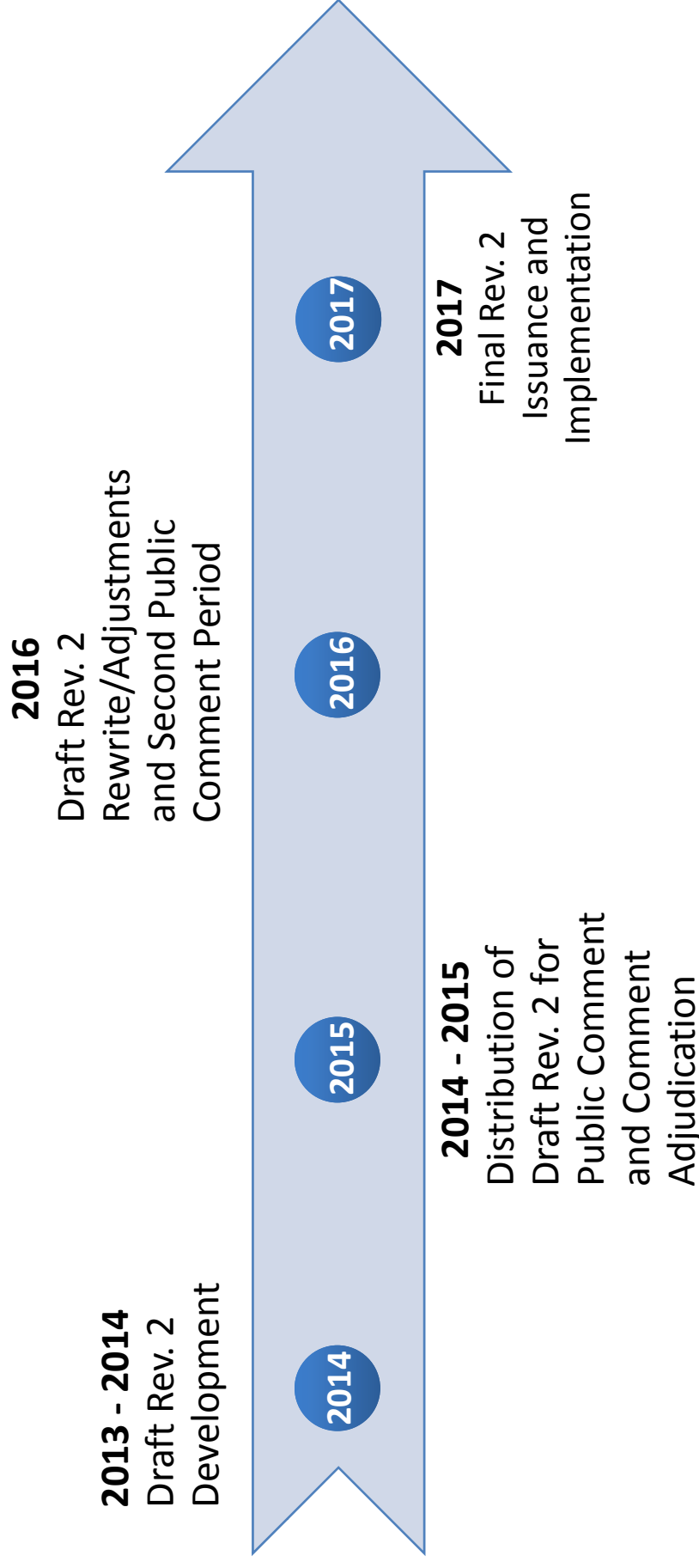
Key Event Milestones
