Hi and happy spring!

I want to update everyone on the status of their KI replenishment.

We will be placing orders for your replenishment stockpiles with an expected delivery in August. We will notify you in advance of the actual ship dates so that you can get prepared for receipt of the shipment. Annette will send emails with the projected ship dates. If you have any changes in your "ship to" location now is the time to let us know.

To help plan for receipt of your shipments:

Each pallet contains 48 cases ( 7680 boxes and 153,600 KI tablets) .  
(each case contains 160 boxes of KI w/20 tablets per box)

Pallet dimension = 44"x40"x40" and each filled pallet weighs 370 pounds. It is possible that for large orders the pallets will be double stacked.

The actual shipping service will be determined based on order size and this information can be provided closer to the actual ship date. If you have any special requirements for delivery such as a 24 hour advance notice, or certain dates are not available for receipt of delivery, please let us know as soon as possible. Thank you.
